

TITLE: Interim Labour Market Partnership formation and planning - Update

Background and Key Issues:

Background

- The Council has been working with the Department for Communities (DfC) and local partners in the design and development of an Interim Action Plan for the new Lisburn and Castlereagh Labour Market Partnership in order to secure a letter of offer. The Interim Action Plan was submitted and re-submitted to DFC for staged assessments in October, November 2021 and January 2022.
- 2. On 30 November 2021 a funding contract was received by the Council for administration and running costs associated with the LMP for the period 30 Nov 2021 to 31 March 2022. These contracts were issued to all Councils and are not linked to programme spend. This has enabled the appointment of an officer on an initial contract (up to March 2023) to work exclusively on progressing this programme of work within the Programmes Team.

Key Issues

 A letter of offer for the 2022-2023 year (or part thereof) is anticipated in the next few weeks for programme expenditure, as is a letter of offer for the Administration spend for the same period. Unfortunately, the recent uncertainties around budget allocations in Stormont are once more creating uncertainties in the approach DfC will take in rolling this initiative out.

- Nonetheless, officers are working to develop appropriate initiatives and programmes of support in advance of any letter of offer where this is possible and practical. This work includes preparation of draft procurement documentation, promotional content, building networks and liaising with potential participants.
- It is anticipated that once some budget stability around the programme is established by DfC, that further reports to committee will include recommendations to secure an appropriate dedicated staffing resource within the Programmes Team on a multi-annual basis.

Recommendation:

It is recommended that the committee considers this update, and continues to signpost any potential programme participants or contacts to the Programmes team.

Finance and Resource Implications:

A funding contract for £70,165.83 has been received to support the administration and running costs associated with the LMP for the period 30 Nov 2021 to 31 March 2022.

This is complemented by a funding contract to March 2023 for £50,000 from the Department for the Economy linked to the skills agenda.

The total additional potential budget that could be allocated to the Lisburn and Castlereagh Labour Market Partnership on final approval of the interim action plan is \pounds 457,535 which is inclusive of an administration budget of \pounds 91,507.00 to support the staffing and running costs of the secretariat. This is anticipated, but not yet secured.

TITLE: Closure of NI Rural Development Programme 2014- 2020 and Lagan Rural Partnership Ltd Local Action Group.

Background and Key Issues:

Background

- Lagan Rural Partnership Ltd is the Local Action Group (LAG) who have responsibility for the delivery of Priority 6 of the NI Rural Development Programme 2014- 2020 (NIRDP) in the rural areas of Lisburn, Castlereagh and Belfast. The NIRDP Programme is funded by the Department of Agriculture, Environment and Rural Affairs and the European Union. The programme administration is managed by the Programmes Team in the Economic Development Unit.
- Chaired by Alderman Allan Ewart MBE, the LAG is comprised of 10 independent social partners and 9 Elected Members as detailed in the first page of the newsletter appended. The role of the LAG will come to an end with the completion of the NIRDP.
- 3. The LAG structure has remained in place for an additional period in order to allow a final evaluation of the programme outcomes in this region and an exit strategy to be developed in fulfilment of the DAERA's requirements. The exit strategy is in reality a transition to closure report cataloguing the electronic and physical data held by the Council in relation to both the NIRDP 2014 2020 and the NIRDP 2007- 2013 programmes. It must also establish post-closure audit and administration arrangements. In the meantime the last remaining projects have drawn down their final claims for retention.

Key Issues

It is now anticipated that the LAG will formally dissolve at the end of March 2022 as their contractual obligations will have been successfully discharged in full and the public funding for which they are responsible (£3.27 million) has been successfully delivered. The final Lagan Rural Partnership Newsletter is attached as (see Appendix). All four of the funding schemes operated by Lagan Rural Partnership have administered their final grant payments and the value of programme achievements is detailed below.

- Lagan Rural Partnership has done much to improve the quality of life of our rural communities through the Basic Services and Village Renewal Schemes. In addition to investing in our rural communities the programme has generated significant results for our local economy in terms of new business, including the creation of 84 jobs.

Many of the LAG members have given up to 13 years of voluntary service to this organisation in order to improve the lives of rural residents and bolster rural businesses. The meeting will be followed by a meal in Lighters Restaurant attended by the Mayor, the Chair of the Development Committee and officers from LCCC.
- 4. An update report will be brought back to the Committee regarding any future replacement schemes arising from the Rural Framework Strategy currently being finalised by DAERA

Recommendation:

It is recommended that the Committee considers and notes the plans for the closure of the NIRDP and the LAG Board and extends appreciation in the manner outlined for their contribution in managing this programme.

Toye Doors Ltd

Founded in 1999 by Stephen McClenaghan, Toye Doors Ltd is a specialist door manufacturer located at La Mon Industrial Estate in rural Castlereagh. The company manufactures a range of high quality and bespoke doors for the private and commercial markets.

At the time of their application Toye Doors urgently required investment to respond to significant growth within the construction and housing markets. The company successfully applied to the Northern Ireland Rural Development Programme's Rural Business Investment Scheme to fund a 5 axis CNC Machine, which greatly reduced production time, allowing for a significant increase in output. It also enabled the

business to broaden the services available to customers, such as fitting high security locks, developing intricate door designs and bespoke orders which set them apart from others.

Lagan Rural Partnership awarded Toye Doors Ltd £50,000 to invest in vital production machinery. The funding had the desired effect of increasing capacity while reducing order turnaround time. The project led to the development of one full time permanent post to assist with the increased workloads. This was a direct result of the new machinery installed under NIRDP funding. In addition the project has enabled the company to break into export markets in the UK Mainland.

Julie A. Robinson Optometrists is an independent optician established in 1985 by Julie Robinson. There are two branches, located in Moira and Crumlin. Both are very well respected practices and have grown over the years, offering a full range of high quality ophthalmic services.

Julie wished to expand the services available at her Moira practice to include specialist Optical Coherence Tomography (OCT) scanning. This machine enables the optician to undertake detailed eye scans allowing the optician to look even deeper into the eye and the structures within it.

Julie A Robinson Optometrists successfully applied for funding assistance under the Rural Business Investment Scheme, administered by Lagan Rural Partnership (LRP) Local Action Group.

She was awarded £14,997.50 in grant funding to purchase dedicated equipment to enable the practice to offer Optical Coherence Tomography (OCT) scanning.

This expert piece of equipment enables precision scans of the eye to show fine measurable changes to the optic nerve and retina and can assist the early diagnosis of some eye conditions including glaucoma, Wet AMD and diseases of the retina.

Not all Optometrists offer this specialised service, therefore, the project has helped Julie to retain existing patients and diversify into a new market, thus attracting new customers. The specialist equipment added another element to the professional eye care services available at the practice and led to the creation of two part time jobs.

"The funding enables us to offer a comprehensive screening service, thus consolidating our position as a dedicated eye specialist offering the most up to date treatment. The OCT equipment enables us to offer immediate results to our patients, thus alleviating stress and anxiety that patients previously experienced when they were referred to the NHS waiting lists for further testing."

Rustbusters NI Ltd is a leading specialist in commercial, industrial and domestic shot blasting and powder coating. This pioneering company, managed by Simon Saunders utilised a gap in the Northern Ireland manufacturing sector to introduce a new service to Northern Ireland and to set themselves apart from their competitors.

The company made the decision to invest in state of the art technology to offer customers within specialist markets a more mechanised and evidence based method of production. This service of certifiable chemical treatment of materials is used consistently within the automotive, aerospace, medical and selected construction sectors which are exposed to rigorous regulations to ensure public safety.

Offering this unique facility enabled the company to become an integral part of the

supply chain. They can now undertake certifiable treatments complete with data sheet read outs necessary for specialist industries.

The applicant successfully applied to the Northern Ireland Rural Development Programme to purchase a Pre Treatment Plant and automated powder coating equipment. They are now the sole provider in the region to have this type of technology, making them a highly innovative and unique company.

Investment has permitted the company to enhance their capacity and speed of delivery to customers. The grant enabled the development of new services to their existing and new trading markets, by providing a dynamic service in the chemical treatment of materials in an automated, controlled environment.

Vision Fabrications was a fledgling enterprise when Barry Lyttle approached Lagan Rural Partnership in Spring 2018. This new company had an urgent requirement for a number of key pieces of capital equipment. The business expanded rapidly and quickly established a reputation for delivering high quality services, specialising in both Architectural Metalwork and Structural Steelwork throughout the UK and Ireland.

At the outset, the company was reliant on outsourcing elements of their business which considerably restricted their production capacity and speed.

The company made a successful application for grant funding to the Rural Business Investment Scheme as a start-up business. The business invested in a CNC Hydraulic Press Break Machine and a CNC Plasma Cutter to enable the company to fully manufacture their steel structures in house; this in turn supported them to improve their output and secure their market position as an export led business.

Lagan Rural Partnership awarded Vision Fabrications Ltd £30,000 in financial assistance. Investment has enabled the company to grow their workforce beyond their target of 8 full-time jobs to 13 full-time jobs. Furthermore they have surpassed their turnover target, predominantly from export sales, proving their investment represents an excellent return on grant deployed and will ensure the sustainability and economic growth of an innovative engineering enterprise.

Managed by the Spence Family, Spence Engineering Ltd have over 60 years' experience in the manufacturing industry primarily servicing the agriculture, quarry maintenance and recycling sectors.

Their business operations include the manufacture and repair of Excavator Buckets, including Hi-Tip Buckets, Quick Change Adaptors, Pallet Forks, Silage Grabs, HTS Cutting Edges, Bucket Pins and Bushes and Hydraulic Rams. As well as carrying out general repairs to excavator and hydraulic equipment both in-house and on-site.

Capitalising on changing market trends Spence Engineering Ltd identified an increased service demand for hydraulic repair work within their existing and potential client base; with additional scope to enter new export markets. The business located at Tullynore Road, Hillsborough applied to the Northern Ireland Rural Development Programmes' Rural Business Investment Scheme for grant assistance to expand the existing business offering through investment in additional capital equipment. The applicant secured funding to purchase 2 Manual Lathes for operation in the main workshop. The machinery has increased production both in number of units and diversity of new products and strengthened exporting avenues.

The company has enjoyed increased success in competitive markets, with a significant increase in turnover and the creation of 5 new jobs.

Bells Lane Allotments

Bells Lane Allotments are owned and managed by Lisburn & Castlereagh City Council. The popularity of the allotments, the demand for a social space and increasingly diverse needs particularly from less abled residents led to the development of this innovative project proposal.

Financial assistance was needed to improve the basic services infrastructure of the existing allotment space and to specifically create one plot for community use, a 'community hub' that would lead to increased accessibility for those with mobility issues. The Council applied to Lagan Rural Partnership for financial assistance to create the following infrastructural improvements:

- Meeting space which provides shelter
- Classroom area
- Toilets with disabled and baby changing facilities
- Raised and accessible beds

- Outdoor seating area
- Car park improvements

Complementary to this was the development of an engaging programme of educational, physical and events-based activities in collaboration with local community groups.

This was one of eight rural basic services projects delivered under Northern Ireland Rural Development Programme in the Lagan Rural Partnership area giving a combined financial assistance total of £818,403.93. Access to Basic Services Scheme supports capital investments which provide access to basic services or improvements in social infrastructure (including activities to reduce isolation or poverty) to improve the welfare and access to basic services of those living in rural areas. All projects funded were in line with their local council's community plan and created basic services infrastructure. Many of the projects supported the development of community hubs.

Streamvale Open Farm

Streamvale Open Farm, based at Ballyhanwood Road, operates as both a working and open farm. The farm is a family run enterprise which has become one of Northern Ireland's top visitor attractions receiving over 150,000 visitors per year.

Over the years the farm has transformed into a vibrant and dynamic tourist attraction which enables visitors to assist with feeding and caring for farm animals. Visitors can enjoy barrel and tractor rides. In addition, Streamvale provide a number of live shows to offer an interactive demonstration of the farming experience and a number of indoor and outdoor play areas. The onsite café produces delicious food and drinks that can be enjoyed by the whole family.

Capitalising on their success, Streamvale sought to expand their offering to include a

state of the art play village for children, creating the only imaginative farm village in Ireland; setting Streamvale apart from the rest of the market as a unique family visitor destination. Streamvale Open Farm was awarded £38,975 of Rural Business Investment Scheme funding to achieve this vision.

Their grant application was the first step in their plan for growth and in doing so it has created a sustainable staff structure. In the 2 years post project, the applicant has achieved a phenomenal increase in sales which illustrates that the play village was instrumental in diversifying the farm's service offering. The business makes a substantial economic contribution to the local community. The project surpassed its estimated job creation target and generated 9 full time jobs in the local area.

Hannahstown Village Renewal Scheme

Following community consultations with local residents and community associations, Belfast City Council applied to Lagan Rural Partnership for financial assistance under the Rural Village Renewal Scheme for two projects in Hannahstown and Edenderry. Only local Councils are eligible to apply to this scheme and they must provide all necessary match-funding to complete the project. The Hannahstown project created a seated amphitheatre event space complete with heritage information panels, hard and soft landscaping and boundary improvements. The works created the only outdoor meeting space in the area thus providing a much needed civic space to improve the quality of life for local residents. The facility has been well used during the subsequent pandemic.

This was one of eight rural Village Renewal Scheme projects delivered under NIRDP in the Lagan Rural Partnership area giving a combined financial assistance total of £750,527.88. The Village Renewal scheme aims to enhance the lives of local village residents through a programme of capital improvements emanating from community consultation and the development of a Village Plan.

Dromara Village Renewal Scheme

Lisburn & Castlereagh City Council applied to Lagan Rural Partnership for financial assistance under the Rural Village Renewal Scheme to create much needed recreational facilities for teenagers and young people in the Dromara area. The Council then embarked on a challenging project that dramatically transformed the facilities at Lagan Park and created a dynamic outdoor space for young people. Improvements were completed to a very high standard and included:

- Footpath improvements to allow safe access to the Lagan Park from the primary school
- Delivery of a new and innovative pump track for use in cycle sport (cycling, skateboarding etc)
- Large sculptural climbing frame

- Re-development of a derelict kick about space into a vibrant games area for football and basketball
- Installation of adult outdoor gym equipment
- · Signage and landscaping improvements

Lisburn & Castlereagh City Council received funding under the Rural Village Renewal Scheme to commission Village Action Plans and implement capital improvements in five local villages. The projects varied widely in terms of scope as they were tailored to meet the needs identified by the local resident populations. The projects were matchfunded by the Council and deliver significant enhancements to the built environment of local rural communities.

TITLE: Delivery of a new Rural Business Development Grant Scheme funded by DAERA under the Tackling Rural Poverty and Social Isolation programme (TRPSI)

Background and Key Issues:

Background

- 1. The above scheme is funded by DAERA as part of the TRPSI Programme. The scheme is administered by the Programmes Team within the Economic Development Unit, and has been successfully delivered for three consecutive years. The first two programmes enabled 43 local businesses to drawdown £127,500 in financial assistance. The third programme, which is currently at claims processing stage is administering grants to 35 local businesses.
- 2. DAERA has now confirmed the roll-out of a new scheme with a grant capped at £4,999 per eligible business, at a match funding rate of 50% from DAERA and 50% from each participating business. The location of the business must be designated as rural under the scheme rules. Capital improvements will remain ineligible for support. DAERA has developed an online application portal for the scheme which is a welcome development for Councils and applicants. It is hoped that this will prevent incomplete and sometimes ineligible applications being submitted. It has yet to be determined if previous successful applicants will be permitted to apply this time round.
- It is anticipated that budgets will be in line with previous allocations. The administration income provided to the Council to part-offset some of the running costs of the scheme will remain at 10%.

Key Issues

- 1. DAERA has indicated that the fourth call for applications under the Rural Business Development Grant Scheme is to open in May and expected to close at the end of that month. DAERA are currently developing a business case for the new programme so not all of the details are confirmed at this stage.
- 2. As with the current programme, it is proposed that the Council also administers the scheme in rural Belfast, for which it will receive an additional modest income. The third tranche of funding currently being processed is expected to result in approximately £6,000 of grant award to projects in the rural Belfast area and an administration contribution of £600 transferring to LCCC. The amount of grant available to BCC businesses will be capped by DAERA, and would be additional to LCCC's allocation.
- 3. The budget for the scheme is yet to be finalised but is likely to remain in the region of £70,000 for LCCC.

Recommendation:

It is recommended that the committee considers and agrees to the roll out of a fourth tranche of the Rural Business Development Grant Scheme in the LCCC and rural Belfast areas, commencing in May 2022.

Finance and Resource Implications:

Administration resource funding is set at 10% of programme budget so circa £7,000 of administration income for Lisburn & Castlereagh rural areas, and circa £600 for rural Belfast area.
