Annual Lisburn Light Festival

Is this activity/policy/project – an existing one, a revised one, a new one? Recurring annual event which has been running each year since 2018/19. This is an updated screening following the first three years.

The Lisburn Light Festival was introduced as an economic development initiative designed to attract footfall (residents and visitors) to the city centre in the run-up to Christmas.

A core element of the Council's Integrated Marketing Campaign each year is focused on the Christmas period. In this context the objective is to drive shoppers into Lisburn City Centre to do the bulk of their Christmas shopping. This initiative supports and complements the LCCC Christmas Campaign providing a focal point in Lisburn City Centre to promote as an additional reason to visit.

What are the intended aims/outcomes the activity/policy/project is trying to achieve?

The overall aim of the Lisburn Light Festival is to maximise the economic contribution into the Council area by attracting spend from inward investors and visitor.

Objectives include:

- To highlight and promote Lisburn City Centre as a positive lifestyle destination, e.g., for shopping, entertainment, arts and culture
- To change perception of the city centre as a Christmas visitor attraction
- To animate the city centre over the Christmas period
- To increase the public's perceptions of the area as a result

Who is the activity/policy/project targeted at and who will benefit? Are there any expected benefits for specific Section 75 categories/groups from this activity/policy/project? If so, please explain.

The Festival is not targeted at any Section 75 group or any particular section of the public. It is promoted to encourage people from all backgrounds, residents and visitors, to visit the city to enjoy shopping and other activities over the Christmas period. The Festival includes events and activities designed to appeal to all ages.

Economic Development department, Lisburn & Castlereagh City Council, developed the Festival originally with funding from the Department for Communities and input from other public sector partners, e.g., Transport NI and NIE.

	LCCC ensure appropriate and visible signage at all events and displays warning of flashing lights/ strobe lighting.

	The City Centre Team have consulted with external organisations such as Autism NI, RNIB, Epilepsy Action NI, Action on Hearing Loss to seek advice and guidance on how best to manage the lighting and sound display. Special relaxed nights are scheduled which will offer the opportunity to view the light attractions with quieter music and fewer lights switched on.
	LCCC ensure that employment of the appropriate number of first aiders trained to deal with particular issues that may be related to those with sensory sensitivities and/or motor impairments throughout the light festival's planned events.
Dependants	People with dependents or disabled family members may require access to toilet facilities during the planned events. The Museum toilets are open to the public during working hours.
